- 2. The Chairman welcomed all the members/representatives of the different Association/organizations. No points were received in advance from trade within the stipulated date for the TFC meeting.
- 3. To begin with, the Chairman briefly reviewed the outcome/action taken w.r.t the points/decision taken in the earlier TFC.
- 4. The following points were received for discussion in the current CCFC/ TFC Meeting:

PART-I

MAO, Goa has proposed the following 5 points:

1. Green channel may be provided for all the Naval consignment being imported including consignment import post repair.

Comments of the Commissioner

Being defense procurements all care has been taken by the Customs, Goa for speedy clearance of the imports. Further, MAO, Goa is requested to get themselves registered under Authorized Economic Operator Program, as under the said program there will be minimum intervention from Customs and most of their consignments can be cleared on RMS basis. For getting registered under Authorized Economic Operator Program, the officials concerned of MAO, Goa may approach the client relation manager and the Addtnl. Commissioner of this Commissionerate at the earliest. The Customs Broker engaged in facilitating the clearance of MAO, Goa may also get himself registered and Authorized Economic Operator Program.

2. In case of consignment imported post repair, all relevant export documents when dispatched in past are required to be produced for customs clearance formalities, which may not be possible in all the cases, therefore some co-operation is sought in this aspect.

Comments of the Commissioner

The issue is being examined for speedy clearance of those consignments where MAO, Goa is not in a position to provide documents for past exports which are imported back after repair. In such a case, it will be examined at to whether based on an undertaking given by MAO, Goa and their overseas supplier whether the consignment can be cleared on the value declared at the time of re-import of the received goods.

3. Considering the criticality of the sophisticated components the examination to be carried out without disturbing the actual packing.

mments of the Commissioner

In case of sophisticated components which are covered with protective films, instructions are being sued to field formations/ examining staff not to disturb the actual packing and to clear the consignment on the basis of verification of external marks & numbers.

4. All the process involved for customs clearance of naval aircrafts stores may be given higher priority to avoid undue delay and meet operational requirement/ commitment.

Comments of the Commissioner

The Customs have always committed to extend top priority to all the defense procurements in the past and it is assured that in future same courtesy and facility will be extended.

5. The approval of independent bonded store for all the consignments.

Comments of the Commissioner

MAO, Goa and their officials are requested to apply for independent Bonded Store (if not applied) which will be cleared on priority. In case for any clarification in this regard the officials of MAO, Goa may approach AC (Bond) for further assistance.

PART - II

- 1. M/s D-Link have informed that 24 claims of DBK amounting to Rs. 57.87 lac under Section 74 are pending since July, 2016. Necessary instructions have been issued to concerned AC to dispose of above claims within a period of 7 working days. The claimant is requested to approach AC (DBK) to remove or clarify any deficiencies in respect of these 24 claims so that the claims can be disposed of on priority.
 - 2. The dates for the next TFC meeting to be held at the same venue will be informed shortly.
