PUBLIC NOTICE NO. 02/2018

Attention of the Importers, Exporters, Customs Brokers, Shipping Lines/Shipping Agents and all stake holders is invited to the Circular No. 26/2017-Customs dated 01.07.2017 issued by CBEC and Public Notice No. 14/2017 dated 05.09.2017, 20/2017 dated 24.10.2017, 22/2017 dated 09.11.2017 and 27/2017 dated 28.12.2017 issued by this Custom House on the above subject.

- 2. It is informed that the RFID Seal reader has been installed at ICD Verna and those exporters who intend to follow e-sealing procedure may opt for such procedure in respect of exports through ICD Verna. As you are aware that the RFID Seal readers have already been installed at Mormugoa Port; Refer Public Notice No.27/2017 dated 28.12.17.
- 3. All the Exporters intending to adopt e-sealing procedure shall strictly adhere to the instructions/conditions specified in afore mentioned Public Notices. Further, all the exporters should comply with the following before they switch to self sealing procedure;
 - a. The exporter shall submit a list of persons, along with their specimen signatures (maximum three), who are authorized on behalf of the exporter to do the self-sealing and self-certification to the Deputy/Assistant Commissioner of Customs (Import & Export Section), Custom House, Marmagoa as per the format enclosed in Annexure "A".
 - b. The exporter shall submit copies of their identity proof (with photograph) and proof of address of each individual authorized signatory attested by the exporter along with a certificate of signature verification from any of the

Scheduled Commercial Banks to the Deputy/Assistant Commissioner of Customs (Import & Export Section), Custom House, Marmagoa (Copies of Bank Pass Book/ Aadhar Card would serve the purpose of proof of identity & address).

- c. The exporter shall intimate the shipment/ self-sealing particulars to the Deputy/Assistant Commissioner of Customs (Import & Export Section), Custom House, Marmagoa at least one day in advance each time self-sealing is carried out at the approved premises. The intimation, in this regard shall clearly mention the place and address of the approved premises, description of export goods and whether or not any incentive is being claimed.
- d. In case, the RFID seals of the containers are found to be tampered with, then mandatory examination would be carried out by the Customs authorities.
- e. The self-sealed containers shall accompany Examination Report as per format enclosed as Annexure 'B' and all other relevant documents.
- 4. Difficulties if any should be brought to the notice of the Deputy/Assistant Commissioner of Customs(Import & Export Section), Custom House, Marmagoa.
