PUBLIC NOTICE NO: 04/2017 (Addendum)

Sub: Clarification regarding recovery of Merchant Over Time-reg.

Attention of the Trade & Industry is invited to the Public Notice No. 04/2017 dtd 07.02.2017 F.No S/14-119/2017 (I & E) on the above subject.

2. After Parall of the above Public Notice following Para is added to the Public Notice No. 04/2017 dtd 07.02.2017.

Para 12:- Vide Notification No. 46/2016-Customs (N.T.) dtd 01.04.2016 the Central of Board of Excise and Customs amended the Customs (Fees for Rendering Services by Customs Officers) Amendment Regulations, 2016. They shall come into force on the date of their publication in the Official Gazette;

In regulation 3, after the table, the following provisions shall be inserted, namely:- Provided that where the working hours in respect of clearance of cargo in Customs ports or Customs airports, has been prescribed as twenty-four hours on all days for customs clearance, no fee shall be leviable in such locations for the services rendered by the category of officers mentioned in column (1) of the Table. (For Col (1) of the table refer Regulation 3 of above Regulations)

3. Further, attention of Trade & Industry is invited to the Customs (Fees for Rendering Services by Customs Officers) Regulations 1998; wherein, the following has been defined.

REGULATION 2. Definitions. - In these regulations unless the context otherwise requires-

- (a) "Customs Officer" includes such officers as are appointed under section 04 of the Customs Act, 1962 (52 of 1962);
- (b) "Custom Work" means functions to be performed by Customs Officer under the Customs Act, 1962 (52 of 1962) or any other law for the time being in force;
- (c) "Rendering Services by Customs Officers" means-
 - (i) Performance of Customs work by the Customs Officer beyond the working hours but within the Customs area; and
 - (ii) Performance of Customs work by the Customs Officer beyond the Customs area at any time, and includes-
 - (a) Examination of the goods and related functions,
 - (b) Loading and unloading of the goods whether generally and specifically,
 - (c) Escorting goods from one custom area to the other, and
 - (d) Any other Customs Work authorized by the [Principal Commissioner of Customs or Commissioner of Customs, as the case may be];

(d) "Working Hours" means the Duty hours prescribed by the [Principal Commissioner of Customs or Commissioner of Customs, as the case may be] in his jurisdiction for normal Customs work and where different working hours have been prescribed by the said [Principal Commissioner of Customs or Commissioner] for different items of Customs Work or for different places within his jurisdiction, such working hours.
