PUBLIC NOTICE NO. 08/2020 (GOA)

In exercise of the powers conferred under Section (45) of the Customs Act, 1962 (52 of 1962), I, Mihir Ranjan, Commissioner of Customs, Goa hereby appoint M/s. Airport Authority of India, Cargo Logistics and Allied Services Company Ltd. (AAICLAS), Goa, having its registered office at AAICLAS Complex, Delhi Flying Club Road, Safdarjung Airport, New Delhi - 110 003, with its terminal at Dabolim International Airport, Airports Authority of India Goa, 403801 as the Custodian for EXIM operations including trans-shipment cargo and Unaccompanied Baggage till its clearance at the Goa Air Cargo Complex INGOI4.

2. Being the Service provider the Custodians shall abide and comply with terms and conditions laid down in Notf. No. 26/2009 -Cus (N.T.) dated 17.03.2009 'Handling of Cargo in Customs Areas Regulations 2009' and Circular No. 13/2009-Customs dated 23.03.2009 as well as Rules & Regulations and instructions issued from time to time.


3. As regards the Imported Cargo landing at the Dabolim Airport, the Custodians shall request the A.C.(Admn) Dabolim Airport, to depute an Officer to escort the Cargo landed from the point of landing to the Warehouse and same shall be done under Preventive supervision.

4. Any alterations in the plan in the Customs area as notified as per Notification no. 02/2014-Cus dated 05.03.2014 shall be made only with the concurrence of the Commissioner of Customs Goa.

5. In order to monitor the implementations of the Regulations and ensure compliance by the Custodians, the Assistant Commissioner (Admn) at Dabolim Airport has been appointed as the Nodal Officer.

6. The Custodianship is initially appointed for a period of 2 years and Commissioner of Customs shall has the right to terminate the appointment at any time during the period after assigning specific reason and giving opportunity to the Custodians to explain their case. The appointment shall be reviewed after two years thereafter.
