PUBLIC NOTICE NO. 11 / 2017

**Sub:- Launch of Indian Customs EDI System - (ICES - 1.5) for Imports and Exports,  
at ICD Verna, [IN MDG 6] Taluka- Salcette, District South Goa - Reg**

1. It is brought to the notice of all exporters, importers, Custom House Brokers Custodians, Banks, Trade and all concerned that the computerized processing of Bills of Entry and Shipping Bills under the Indian Customs EDI(Electronic Data Interchange) System, hereinafter referred to as ICES 1.5, will commence from 04/8/2017. Inland Container Depot Verna, [INMDG6] developed by M/s. Central Warehousing Corporation (Verna), M50-54, Phase III B, Verna Industrial Estate, Verna Dist. South Goa - 403722 which was notified as Inland Container Depot (ICD) vide Notification No. 12/1997-Customs (N.T.) dated 02.04.1997 as amended by Notification No.6/2001 under Clause (aa) of Section 7 of the Customs Act, 1962 issued by Central Board of Excise & Customs. M/S Central Warehousing Corporation were appointed as Custodians vide Public Notice No.28/2001 dated 17/4/2001 under Section 45(1) of the Customs Act, 1962 which was further amended vide Corrigendum dated 30/12/2011 issued by this office. **One Assistant Commissioner and one Superintendent of Customs are posted for a period of one year initially on Cost Recovery Basis. All other required formalities including pre-production have been completed successfully.**

1.1. As part of the implementation of CBEC's IT Consolidation Project, the EDI operations at ICD Verna, Taluka Salcette, District South Goa, Goa would be on ICES 1.5 application, which is the centralized version of the ICES 1.0 application, earlier implemented on standalone servers at major Customs locations. The ICES 1.5 software, developed by NIC, has been implemented at CBEC's National Data Centre at New Delhi. The System Integrator for the project is M/s TCS. The application would cater to the needs of Customs officials at ICD Verna, Taluka Salcette, District South Goa, Goa and also the Service Centre operators, internet broadband connection provided by BSNL and connectivity to the Central servers at the National Data Centre has been provided through CBEC's VPN network.

**NOTE:** The State Bank of India, Verna Industrial Estate Branch, (BSR Code: 0004338) at ICD Verna is the designated bank for disbursing drawback and collection of Duties, Cess etc for ICD Verna.

Exporters intending to claim chapter 3 benefits are required to declare "Y" in the item segment of Reward claimed ( Table 28(14)) without which their Shipping bill will not be transmitted to DGFT for availing such benefits.




