Public Notice No.:- 13/2018

It is proposed to conduct an Examination under Regulation 13(5) of CBLR, 2018 in the month of November, 2018 for employees of Licensed Custom House Agents/Customs Brokers. All existing 'H' Category Customs Pass holders as on 31.12.2018 are eligible to appear in the aforesaid examination. The exact date and time of examination will be notified in due course.

- 2. All eligible candidates may apply in the prescribed form available on the Departmental Notice Board of Customs House, Marmagoa, Goa. The application form (Annexure A) along with the admission card duly filled should be accompanied by the following documents:
 - a. Two recent photographs (One photograph attested by the CHA/C.B.Licensing authority)
 - b. Copy of the CHA/C.B.License attested by the CHA/C.B. Licence Holder.
 - c. Copy of "H" Category Customs Pass attested by the CHA/C.B.License Holder.
 - d. Copy of proof of education qualification (10+2) attested by CHA/C.B. License Holder.
 - e. Copy of Salary certificate issued by CHA/C.B.License Holder.
 - f. Copy of proof of Residential address, attested by CHA/C.B.licence Holder.
- 3. The application form and the admission card completed in all aspects along with the enclosures should be submitted at Custom House, Marmagoa, Goa by not later than 07.12.2018. No application form will be received elsewhere in the Commissionerate.
- 4. Any deficiency found during scrutiny will be displayed on the Notice Board. The deficiency in document submitted can be rectified by the applicant within 2 days by submitting the due documents/correspondence at Custom House, Marmagoa. No correspondence/personal visits shall be entertained by any Section in this regard. No correspondence for removal of deficiency will be entertained after 5.00 p.m. on 07.12.2018. The incomplete application in any aspect or with wrong information is liable to be rejected.
- 5. The Roll numbers will be displayed on or before seven days of the examination on the Notice Board of Customs House, Marmagoa, Goa. The Admission card will be issued to all eligible candidates before the examination and the admission card shall be given only to the applicant on production of his "H" Category Customs Pass for identification. The Time, dates and place of examination will be confirmed to the participants.

6. Each applicant would be permitted to avail of maximum of four chances/attempts to qualify in the written and oral examination from the date of his/her first appearance for the written and oral examination form the date of his/her first appearance for the written examination. A person who qualifies in the written examination in the first chance/attempt but fails to qualify in the oral exam immediately after the written examination will get three more chances/attempts for oral examination.

7. Non appearance in the examination after issue of admission card shall be treated as an attempt availed. Each candidate must bring his/her valid "Hv-Category Customs pass and admission card failing which he/she will not be permitted to appear in the examination.

8. Syllabus of the examination will be as per Annexure B enclosed.

9. Eligibility for category G Examination:-

An employee/Director/partner of the Customs Brokers holding a valid 'H'Card under regulation 13 of CBLR, 2018 and working in the jurisdiction of Goa Customs Commissionerate, and who has passed 10+2 or equivalent exam shall be eligible to apply for the Category G examination. If any applicants claim their qualification as equivalent to 10+2 Exam, such applications should be accompanied with a certificate from the respective State Secondary Education Board certifying that such qualification is equivalent to the 10+2 exam conducted by such State. Applications which are not accompanied with this certificate will be summarily rejected.

10. All Customs Brokers are advised to ensure that the information given in respect of their employees is true. Any mis-declaration will be viewed seriously and suitable action will be taken in accordance with CBLR, 2018. Customs Brokers are also required to ensure that the H-card held by the candidates are duly renewed well in advance, if the same expires before the date of examination. Candidates holding invalid H-cards will not be allowed to appear for the Exam. In case any candidates leave their job after submitting application for the Exam, the concerned Customs Broker should forthwith report the matter to this office and surrender the original Hcard held by such candidate.

11. The issue of Admit Card or appearance in the examination shall not be construed as acceptance of the declaration or particulars submitted by the applicant.
