PUBLIC NOTICE NO. 13 /2020 DATED: 11.06.2020

Subject: Renewal of the Custodianship of M/s. Adani Mormugao Port Terminal Pvt. Ltd, Mormugoa Harbour Goa-reg

The Mormugao Port Trust Coal Terminal at Berth No. 7, was declared as Customs Area under section 8 of the Customs Act, 1962 vide Notification No. 01/2013-Cus dated 11.05.2013, and M/s Adani Mormugao Port Terminal Pvt. Ltd., Mormugoa Harbour, Goa was appointed as Custodian vide Public Notice No. 11/2014 dated 27.03.2014 for five (5) years, under section 45(1) & 141(2) of the Customs Act, 1962 and regulation 10 of the HCCA Regulation, 2009.

2. Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, Mihir Ranjan, Commissioner of Customs, Goa, hereby renew the appointment of M/s. Adani Mormugao Port Terminal Pvt. Ltd., Mormugoa Harbour as "Custodian / Customs Cargo Service Provider (CCSP)" of the Imported goods received at Mormugao Port Trust, for Coal Terminal at Berth No. 07, until they are cleared for home consumption or are warehousing or are transhipped in accordance with the provision of the Customs Act, 1962.

3. Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009", I, Mihir Ranjan, Commissioner of Customs, Goa, hereby renew the appointment of M/s. Adani Mormugao Port Terminal Pvt. Ltd. as a 'Custodian/ CCSP' for the above-mentioned Mormugao Port Trust Coal Terminal at Berth No. 7, subject to following conditions:

(i) The Custodian /CCSP M/s. Adani Mormugao Port Terminal Pvt. Ltd , appointed as Custodian for the said Terminal Berth No. 7 shall abide by all the provisions of the Customs Act, 1962, Handling of Cargo in Customs Areas Regulations, 2009, and other regulations, notifications, orders issued under Customs Law or any other law.

(ii) The duration of appointment of M/s. Adani Mormugao Port Terminal Pvt. Ltd. as 'Custodian/ CCSP' shall remain valid for a period of five (05) years from 27.03.2019, unless otherwise suspended/ revoked/ cancelled prior to the expiry of the said period.

4. The Custodian/CCSP shall apply for the renewal of the license at least two months before the date of expiry of the license without fail. In event of failure to do so no clearances shall be permissible between the period after expiry of the license and its renewal.

5. The Commissioner of Customs, Goa shall have the Right to review the appointment of M/s. Adani Mormugao Port Terminal Pvt. Ltd. as 'Custodian/ CCSP', anytime for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations, 2009 or as per the directions of the Government of India.
