PUBLIC NOTICE NO. 15/2020 DATED: 17.06.2020

Sub - Renewal of the Custodianship of the Deepwater Jetty site & structures at South West Port Ltd. (SWPL), Goa-reg.

The Deepwater Jetty site & structures at South West Port Ltd. (SWPL), Mormugao Port Trust, was declared as Customs Area under section 8 of the Customs Act, 1962 vide Notification No. 01/2005-Cus (NT) dated 27 04 2005, and M/s. South West Port Ltd. (SWPL), Mormugao Harbour, Goa was appointed as Custodian vide Notification No. 02/2005-Customs (NT) dated 02 06 2005 and was renewed vide letter F.No. S/14-20/2004- I&E dated 10.09.2012 for five (5) years w.e.f 23 06 2012, under section 45(1) & 141(2) of the Customs Act, 1962 and regulation 10 of the HCCA Regulation, 2009

2. Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act 1962, I, Mihir Ranjan, Commissioner of Customs, Goa, hereby renew the appointment of M/s. South West Port Ltd. (SWPL), Mormugao Harbour, Goa as "Custodian / Customs Cargo Service Provider (CCSP)" for unloading of imported goods and loading of export goods brought at the said place until these are cleared for home consumption or exported or are warehoused or are transhipped in accordance with the provision of the Customs Act, 1962.

3. Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations 2009", I, Mihir Ranjan, Commissioner of Customs, Goa, hereby renew the appointment of M/s. South West Port Ltd. (SWPL) as a 'Custodian/ CCSP' for the above-mentioned Deepwater Jetty site & structures at South West Port Ltd. (SWPL), subject to following conditions:

(i) M/s. South West Port Ltd. (SWPL), appointed as Custodian/CCSP for the Deepwater Jetty site & structures at South West Port Ltd. (SWPL) shall abide by all the provisions of the Customs Act, 1962, Handling of Cargo in Customs Areas Regulations, 2009, and other regulations, notifications, orders issued under Customs Law or any other law.

(ii) The duration of appointment of M/s. South West Port Ltd. (SWPL) as 'Custodian/ CCSP' shall remain valid for a period of five (05) years from 23 06.2017, unless otherwise suspended/ revoked/ cancelled prior to the expiry of the said period.

4. The Custodian/CCSP shall apply for the renewal of the license at least two months before the date of expiry of the license without fail. In event of failure to do so no clearances shall be permissible between the period after expiry of the license and its renewal.

5. The Commissioner of Customs, Goa shall have the Right to review the appointment of M/s. South West Port Ltd. (SWPL) as 'Custodian/ CCSP', anytime for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations, 2009 or as per the directions of the Government of India.
