2. Functions of the Committee: The Committee will meet to sort out the grievances of the trade and Industry vis-à-vis the functioning of Customs under the Commissionerate of Customs, Marmagoa and initiate necessary action for their prompt redressal.

3. Life Period of the Committee:- The Committee shall function for the period of two years and accordingly the term of office of each nominated member will be from April 2017 to March 2019. However, should the occasion arise to nominate a member in between, his tenure of office will be for the remaining period of the life period of the committee. On expiry of the term of the Committee, a fresh Committee will be constituted.

4. Meeting of the Committee: The Committee shall normally meet once in two months at Custom House, Mormugoa as may be specified from time to time

5. If any member nominated on the PGC, remains absent for 3 consecutive meetings without adequate reasons, he shall be deemed to have withdrawn/resigned from the committee and his place will be filled up by a fresh nomination.
