Subject:-Conduct of online examination under Regulation 6 of Customs Brokers Licensing Regulation, 2018 by the National Academy of Customs, Indirect Taxes and Narcotics (NACIN), Faridabad-reg.

The written examination of Customs Brokers Licensing Examination 2020, as amended shall be conducted by NACIN on 06.03.2020 at the designated examination centers across India.

Completed application is to be submitted from 14.10.2019 to 15.11.2019 up to 06:00PM in person or by Registered/speed post in Form-A(available in the CLR,2018) along with two passport size photos and self-attested documents on citizenship (Aadhaar/PASPORT/Voter Card), education qualification , financial viability, mobile number, email id and other requirements along with the prescribed fee of Rs. 500/- (Rupees Five Hundred only) to the Commissioner of Customs having jurisdiction over the area where the applicant intends to carry on his business. Application sent by post, in case received after the last date shall not be entertained.

The online written examination will be Computer Based Exam with Multiple Choice Questions (MCQs) of two and a half hours (10.30. hrs. to 13.00 hrs.) duration. Questions will be bilingual i.e. in English and Hindi. The pattern of examination will be as follows:

The syllabus of examination is prescribed in Regulation 6(7) of the Customs Brokers Licensing Regulations, 2018 as amended. Those qualifying in the said examination will have to appear for oral examination in terms of Regulation 6 of the said Regulations.

The oral examination will be held during the second quarter of the calendar year 2020. The pass percentage marks for qualifying in the oral examination will be 60%.

A dummy question paper for the purpose of awareness of candidates will be made available on the CBIC and NACIN websites www.cbec.gov.in and www.nacin.gov.in. Under the icon/tab<CSTP/CBLR EXAM> from February, 2020. A link to download the admit card will also be provided therein. Admit card shall also be sent by e-mail to eligible applicants 15 days in advance before the date of examination. For convenience of candidates, other necessary details like list of centres, guidelines to the candidates, help desk, email.id. etc. will also be made available under the said icon/tab.
