STANDING ORDER NO. 06/2018

Sub: Observations and concerns regarding electronic seals used or Export containers - reg.

Reference is invited to the information which has been received from the Risk Management Centre for Customs, Directorate General of Analytics and Risk Management, Mumbai, on the above subject.

- As per the information, some manufacturers of Electronic seal are 2. supplying seals which can be passed by the Customs at Port gate and the particular seal can be scanned at a distance of few meters without being in locked condition.
- It was found that RFID e-seals provided/supplied by M/s Leghorn Group, Italy have been found to have not complied with the security requirement. The following three vendors have procured e-seals from Leghorn Group.
 - (i) M/s IB Track Solutions Pvt Ltd.
 - M/s Great Eastern ID Tech Pvt Ltd, Gurgaon , Haryana. (ii)
 - M/s Perfect RFID Technologies Ltd.
- In this regard, vide Public Notice No. 11/2018 dated 02.11.2018, Exporters have also been advised to refrain from using the e-seals procured from the above mentioned three e-seal vendors until further orders.
- If the export containers having RFID e-seals procured from the above 5. mentioned three e-seal vendors are noticed at the time of scanning, the Preventive Officer at the Major Bunder Gate will verify whether the e-seal is properly locked or not and inform the Shed Appraiser concerned about the



same who will take appropriate decision regarding examination of the said container on the basis of the perceived risk as deemed fit.

6. Any difficulty, experienced in the implementation, may be brought to the notice of the Assistant Commissioner of Customs, Export Promotion Cell, Custom House, Marmagoa.
