OFFICE ORDER

Kind attention is invited to the Order No. 40-3/2020-DM-I(A) dated 15.04.2020 whereby the Ministry of Home Affairs have issued consolidated revised guidelines on the measure to be taken by the Ministries/ Departments of Government of India, State/ UTs for containment of COVID-19 in the country. Further, attention is also invited to the CBEC's Order issued vide F. No. C.50/30/2020. Ad.II dated 15.04.2020 reiterating the said guidelines to be followed scrupulously.

- 2. Vide Para 3 read with para 18 (i) of the said Order dated 15.04.2020, the office of the Government of India viz., Customs will remain open and to function without any restriction with effect from 20th April, 2020. Also, vide Para 17 of the said Order, movement of persons is allowed in the exempted categories.
- 3. Accordingly, all the Officers/ Staff members of the Goa Customs Commissionerate are hereby directed to attend the office with effect from 20th April, 2020 on a daily basis.
- 3. The Deputy/ Assistant Commissioners of the Goa Customs Commissionerate are directed to ensure the presence of the staff in their respective sections for unhampered functioning of the office. Any exemptions to the staff shall be decided by the Commissioner of Customs, Goa on merit, on case to case basis, in terms of the above-mentioned guidelines.
- 4. Further, the Deputy/ Assistant Commissioners shall ensure that Social distancing norms as specified shall be maintained and an Advisory issued by this office vide Circular dated 13.04.2020 should be strictly followed in their respective sections.
