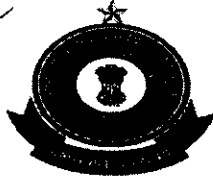


**Sub: Personal Hearing Notice -reg.**

This is in reference to the Hon'ble CESTAT Order No. A/89986-89987/17/CB dated 26.09.2017 arising out of Order-in-Original No. 04/Commr./Goa/Customs/2008 dated 21.10.2008 passed by the Commissioner of Central Excise & Customs, Goa against the show cause notice F. No. DRI/MZU/GRU/INV-02/SBRPL/2005 dated 19.12.2006.

2. With reference to above, I am directed to inform you that the Commissioner of Customs, Custom House, Marmagoa, Goa has granted a personal hearing **on 16.09.2020 at 12.00 Noon.**
3. The Personal hearing will be held in the Chamber of the Commissioner of Customs, 3<sup>rd</sup> Floor, Custom House, Marmagoa, Goa.

Due to outbreak of COVID-19, with a view to adopt measures to ensure social distancing, reduce physical presence, use modern information and communication technology systems and change conventional mode of work, Central Board of Indirect Taxes & Customs, has introduced virtual mode for personal hearing vide Instructions dated 27.04.2020 in F. No. 390/Misc/3/2019-JC wherein the party shall give his consent to avail this facility for personal hearing.
