

You are therefore, requested to attend the same along with all relevant documents pertaining to the matter on **10th September, 2020 at 3.30 PM** to this office, failing which the case will be decided ex-parte on merit as per records available with this Department. Additional Submissions can also be submitted in this regard if any.

Due to outbreak of COVID-19, with a view to adopt measures to ensure social distancing, reduce physical presence, use modern information and communication technology systems and change conventional mode of work, Central Board of Indirect Taxes & Customs, has introduced virtual mode for personal hearing vide Instructions dated 27.04.2020 in F. No. 390/Misc/3/2019-JC wherein the party shall give his consent to avail this facility for personal hearing.
